## **Good News for the Animals!**

### ***AB 1634, California Healthy Pets Act, Passes Assembly Floor and Moves to State Senate Committee***

The California Healthy Pets Act (AB 1634) overcame one more hurdle on its way to becoming law and passed the assembly floor in early June. It now moves on to the state Senate and will be considered by the Senate Business, Professions and Economic Development Committee in early July (refer to the [Action Items](#) section for more information).

### ***Horse Slaughter Ban Upheld in Texas***

Despite threats that horse slaughter would be legalized by a stealth floor amendment in the final Texas state legislative session, the effort did not succeed and the ban remains.

## ***HR 2337 Energy Bill Passes Committee***

The House Natural Resources Committee passed HR 2337, legislation that would offer a crucial lifeline to polar bears, monk seals and other wildlife threatened by global warming. ## ***S 1406/HR 2327 (Polar Bear Protection Act) Passes Committee***

The Senate Appropriations Committee approved an amendment to prohibit the import of sport-hunted polar bear trophies into the U.S. The amendment stops funding for the U.S. Fish and Wildlife Service to issue permits for the importation of sport-hunted polar bear trophies for one year. ## ***Anti Foie Gras Bill Introduced in Philadelphia***

An anti foie gras bill has recently been introduced in Philadelphia, joining other compassionate cities in the U.S. to outlaw the practice of force-feeding ducks and geese for this cruel cuisine.

## ***Forplay Goes Fur-Free***

Forplay recently announced the following to PETA: “[I]n an effort [to] reflect good corporate citizenship, Forplay Inc. has instituted a NO FUR policy effective immediately. Thank you for taking the time to discuss this important issue with me and I hope that our efforts will spare the lives of some animals.” Forplay Inc.’s compassionate decision to stop selling fur will help spare countless rabbits and other animals from needless pain, suffering, and death.

## ***Chicago's Foie Gras Ban Remains***

A federal judge dismissed a lawsuit filed by the Illinois Restaurant Association to overturn Chicago's foie gras ban. The judge summed up her 26-page ruling by stating, “Chicago's ban of foie gras sales in restaurants does not exceed the city's home rule powers or violate the dormant Commerce Clause. Thus, the Ordinance does not violate the Illinois or U.S. constitutions.”

## ***OR Governor Signs Farm Animal Cruelty Bill into Law***

The Oregon governor signed legislation prohibiting a particularly inhumane method of confining animals on factory farms. The new law will bar the use of gestation crates to confine breeding sows in the pig industry. Oregon is now the first state in the country to ban the use of gestation crates by action of a state legislature; Arizona and Florida have done so through voter ballot initiatives.

While this is more good news for sows, the 2007 Farm Bill's Section 123 (federal legislation) would override any state and local animal protection laws (refer to the [Action Items](#) section for more information).

## ***Action Items – Your Letters/Calls Needed***

### ***Urge State Senate Committee to Support AB 1634, California Healthy Pets Act***

After recently passing the Assembly Floor, the California Healthy Pets Act (AB 1634) now moves to the the Senate Business, Professions and Economic Development Committee in early July for a vote.

The California Healthy Pets Act will save taxpayers millions and provide a humane alternative to euthanizing hundreds of thousands of unwanted animals who end up in local shelters. This law would require that nearly every dog and cat in the State of California be spayed or neutered, with certain exemptions provided. Hundreds of supporters for the bill made the trek to the State Capitol in support of this critical legislation.

### ***Urge U.S. Representative to Oppose Section 123 of 2007 Farm Bill***

A subcommittee in the U.S. House of Representatives has recently drafted language for the upcoming 2007 Farm Bill which could effectively block crucial advancements in state and local animal protection laws.

If enacted, this federal legislation would override any state and local animal protection laws – whether passed by state legislature or by voters. We agree with the Last Chance for Animals' statement: "This is an outrageous power grab that would completely undermine the democratic process and deny citizens the right to pass state and local laws on issues of humane treatment or food safety."

### ***Ask State Assembly Members to Oppose SB 880 and Stop Sale of Kangaroo Products in CA***

Unfortunately, SB 880 – the bill that would overturn an over 30-year prohibition on the sale of kangaroo products in California – passed the California Senate earlier this month. This bill now moves to the Assembly Water, Parks and Wildlife Committee for a vote.

### ***Tell Amazon to Stop Selling Cockfighting Magazines***

Amazon.com is being targeted by activists for its continued sale of two cockfighting magazines, The Gamecock and The Feathered Warrior. According to The Humane Society of the United States (HSUS), which sued Amazon.com and the publishers of these magazines on February 8, 2007 for violating federal law, Amazon.com is the only outlet for cockfighters to buy and sell subscriptions over the Internet. The law being violated is the federal Animal Welfare Act which has a provision banning the interstate shipment of fighting birds. Amazon calls what it's doing free speech, but HSUS argues that the First Amendment does not protect a company's right to solicit illegal behavior and peddle contraband. Amazon does not sell magazines that advertise the sale of narcotics, child pornography, or other illegal materials. The same standard should apply to all staged animal fighting publications including cockfighting magazines.

Please tell Amazon you do not support the sale of cockfighting magazines and ask your friends and family to do the same. Tell Amazon you will not buy books or other merchandise from Amazon.com until the company stops promoting cockfighting and violating federal law.
