Good News for the Animals!

AB 1122 Passes Out of Senate Public Safety Committee

AB 1122 passed out of the Senate Public Safety Committee with the support of the chairman as well as the Republican vice chairman.

California Assembly Bill 1122 will prohibit the sale of animals on roadsides and in parking lots. Many of these animals are bred and raised in poor conditions and sick at the time of sale—and since dogs and cats sold in this manner usually are not spayed or neutered, they contribute to the pet overpopulation that leads to tens of thousands of homeless animals being euthanized in the state each year.

If passed, this humane legislation will: eliminate the profit motive from people who sell sick animals, and protect consumers from unscrupulous breeders. The bill contains language that exempts adoption events run by humane societies and legitimate animal rescues.

Turkey Abusers Convicted and Jailed

A 2008 undercover investigation at the Aviagen Turkey breeding facility in Lewisburg, West Virginia, resulted in 19 grand jury indictments, including 11 felony charges, against three former Aviagen workers. PETA, which conducted the investigation and fought successfully for criminal conviction of two of the employees thus far (a third case is pending), said that this is “the first time in U.S. history that factory-farm employees faced felony cruelty-to-animals charges for abusing birds.”

Major Victories for Animals in Oregon

Exotic Pets

After years of delaying action on this important public safety and animal welfare measure, the Oregon legislature finally passed **S.B. 391**, which phases out the private, unlicensed ownership of exotic animals such as big cats, primates, crocodiles, and alligators.

Puppy Mills

Man's best friend won a major victory with the passage of **H.B. 2470**, which cracks down on puppy mills -- large scale facilities that mass produce puppies for sale in pet stores and over the Internet. H.B. 2470 limits the size of puppy mills in Oregon; requires basic animal welfare standards, including banning wire cages and stacking; and protects consumers who purchase sick puppies from these facilities. Prior to this year, Oregon did not have any laws addressing puppy mills, but passage of this bill makes Oregon's laws some of the strongest in the country.

Horse Protection

With horse owners struggling in hard economic times, some take the irresponsible step of simply abandoning their animals on private property, public lands, and even roads and highways. S.B. 398 adds horses and other equines to the existing animal abandonment statute, making horse abandonment a Class B Misdemeanor.

Cockfighting

The legislature also passed legislation (S.B. 280) making it a felony to be a spectator at a cockfight. While cockfighting and possession of birds for fighting are already felonies in Oregon, watching a cockfight was only a misdemeanor, creating a huge loophole. After Governor Kulongoski signs S.B. 280 into law this loophole will be closed, which will help law enforcement crack down on animal fighting in Oregon.

Other Animal Protection Measures

Lawmakers also considered and rejected measures that would require the state to provide a specified amount of land for hunting, and would have required landowners to kill wild pigs on their property.

Dog Fighting Raid Rescues 500 Dogs

Federal law enforcement agencies, along with The HSUS, The Humane Society of Missouri, and the ASPCA, raided multiple dogfighting operations around the country in what was the largest single day of actions against this blood sport in American history. Nearly 500 dogs were rescued and the raid led to arrests in eight states.

With organized dogfighting illegal everywhere and a felony in all 50 states, never in the five-decade fight against this vicious and bloody activity has the message been stronger: dogfighters are a dying breed.

Governor Signs AB 428 to Protect Seals

Despite having said he wouldn't sign any non-budget bills until there was a budget deal, Schwarzenegger signed SB 428 when a state judge issued a 72-hour dispersal demand to the City, who rallied to urge the Governor to act. A stay/emergency motion still needs to be filed to keep the order at bay, but odds are good it will be granted now that state law will be changing on January 1, 2010.

Bolivia Prohibits Wild/Domestic Animals in Traveling Circuses

Bolivian President, Evo Morales, signed the world's first law prohibiting the use of both wild and domestic animals in traveling circuses. To date, Croatia, Singapore, Austria, Israel and Costa Rica have all banned wild animals in circuses. Similar bans on animal use in traveling circuses in Costa Rica, Finland and Denmark only prohibit the use of wild animals or certain species. The law arose as a result of evidence gathered during an undercover investigation by the nonprofit group, Animal Defenders International, proving horrendous abuse to lions, brown bears, wolves, llamas and other animals.

Mojave Hoarders Sentenced

Sentencing of Cindy Bemis and Cynthia Trapani occurred on July 8, 2009. Both women were convicted on May 18, 2009 of 20 combined counts of animal cruelty in Mojave, CA, Kern County. Bemis was sentenced to one year in prison, and her cohort Trapani was sentenced to four months. LCA, along with several other rescue organizations and many dedicated volunteers, made countless trips up to Mojave, CA to feed, care, and trap dogs.

U.S. House Passes Legislation to Protect Burros and Wild Horses

By a vote of 239 to 185, the U.S. House of Representatives passed HR 1018 providing federal protection to burros and wild horses. Known as the Restore Our American Mustangs (or ROAM) Act, the bill is a response to what was found to be woeful mismanagement of the original Act protecting these animals by the Bureau of Land Management.

OCPA thanks its members and others who participated in its recent write-in to help encourage U.S. Representatives to support this important legislation.

Animal Hospital Network Bans Cosmetic Procedures on Dogs

Banfield, the nation's largest veterinary practice with 730 hospitals and 2,000 veterinarians, including many in PetSmart stores, announced it will stop performing cosmetic tail docking, ear cropping, or devocalization (de-barking) of dogs.

Ask Congress to Support Amendments to the Child Nutrition Act

This year, Congress is reauthorizing the Child Nutrition Act, providing a tremendous opportunity to make non-dairy alternatives to cows' milk available as an option for children in school cafeterias around the country.

Currently, virtually all children participating in the National School Lunch Program (NSLP) are automatically served cows' milk, despite the fact that as many as eight million schoolchildren are lactose intolerant, and countless others avoid cows' milk for health, environmental and ethical reasons.

APRL and OCPA held a peaceful foie gras demonstration on Friday, July 10th, from 6:30 to 8:30 p.m. at French 75, 1464 S. Coast Hwy, Laguna Beach, CA 92651; phone: (949) 494-8444.

Foie Gras is created by forcibly restraining ducks 3 times a day while a rough steel pipe is shoved down their throats to overfeed them to the point that their livers swell to more than 10 times the normal size. "If those who purchase and eat this product could only see the diseased organ inside the body of a filth-encrusted duck, the last place they would put this "delicacy" is in their mouths," writes Holly Cheever, DVM, animal cruelty inspector.

The foie gras campaign has resulted in several local restaurants such as Five Feet, the Sky Room, Mr. A's, and Laurel's removing foie gras from the menu.

International Day of Action for Dogs and Cats in Korea – Tuesday, July 14th

The International Day of Action for Dogs and Cats in Korea occurred on Tuesday, July 14th.

In Defense of Animals (IDA) co-sponsored this worldwide event to stop the terrible suffering these animals endure. Demos and other events occurred in San Francisco, Los Angeles, Washington DC, Seattle, New York, Asheville, North Carolina, Ireland, Peru, Bolivia, South Korea, Canada, Ireland, Peru, South Africa and elsewhere. Over 18,000 individually signed petitions were delivered to the Korean Consulate in San Francisco to help put a stop to the abuse of dogs and cats in Korea.

Ringling Brothers Circus Demos – July in Anaheim

OCPA and Last Chance for Animals held a large demonstration against Ringling Brothers' Circus on Wednesday, July 15, opening night at the Honda Center in Anaheim.

Approximately 50 people attended the peaceful demo including visitors from Europe, with two people dressed as clowns (one on stilts), balloons for the kids, and lots of bilingual literature and signs to help educate circus attendees about the truth behind the scenes. One young man and his girlfriend turned around and went home after learning about the circus horrors. Thanks to Bryan of LCA for his literature, signs, balloons, and Helium rental to make the demo a success.

The groups returned to the Honda Center to protest the cruelty of the Ringling Brothers' Circus for the entire week of July 19th, ending with a large protest on Saturday, July 25th and on Sunday, the 26th, the last day of the circus in Orange County. Work will continue on this important campaign throughout the year. Stay tuned for updates.
