Good News for the Animals!

### ***Federal Legislation for Wild Animals Inches Closer to Victory***

The Captive Primate Safety Act and the Great Cats and Rare Canids Act have successfully passed in the House of Representatives. They have passed a Senate Committee and now await a full Senate vote. The Captive Primate Safety Act would stop the inhumane and dangerous practice of trading primates as “pets.” The Great Cats and Rare Canids Act would establish a national fund of up to \$5 million to go toward conservation projects to save 15 species of cats and dogs in the wild.

### ***Egg Recall Draws Media Attention to Plight of Hens***

In late August, close to half a billion eggs were recalled due to a salmonella outbreak – the largest egg recall in U.S. history. This story was covered in major mainstream news outlets including ABC, CNN and others. Included in most coverage was the issue of confining birds in small cages, the unhealthy conditions for the hens, and the link between current production methods and the salmonella outbreaks.

### ***Talbots Goes Fur-Free***

Talbots, a nationwide chain of nearly 600 women’s apparel stores, is once again fur-free. A few weeks ago, concerned citizens reported that they had seen animal fur in the Talbots catalog—a company that had been listed as fur-free in HSUS’s shopping guide. After confirming Talbots’ decision to start selling animal fur after years of being fur-free, the company was bombarded with thousands of messages encouraging them to remove fur; they immediately pulled items containing real fur from their stores. Talbots is to be applauded for retaining its policy against animal fur, and being willing to alter its course of action after realizing it had made a misstep.

### ***Professional Laboratory and Research Services Closes Doors***

Just one week after PETA released the results of its shocking undercover investigation at the North Carolina contract animal testing facility Professional Laboratory and Research Services, Inc. (PLRS)—which uncovered workers’ appalling abuse and neglect of dogs, cats, and rabbits tormented in tests for flea and tick products—and filed a 70-page formal complaint with the U.S. Department of Agriculture (USDA) alleging violations of the Animal Welfare Act, PLRS is shutting its doors for good and surrendering more than 200 dogs and cats left at the facility to animal shelters. The investigation revealed that dogs, cats, and rabbits abused by PLRS suffered from untreated illnesses, injuries, and burns and that many animals were covered with sores that were likely caused by poor housing, stress, and boredom. PLRS employees kicked, threw, grabbed, dropped, and dragged dogs; roughly grabbed and lifted rabbits by their ears; and violently threw and slammed cats into cages.

Thanks to the tremendous outcry of tens of thousands of PETA members and supporters, these mistreated animals will now finally get the veterinary care and loving homes that they deserve.

### ***SeaWorld Fined Over Trainer’s Death***

At the conclusion of its investigation, OSHA issued three citations against SeaWorld over the recent death of a trainer.

### ***Hush Restaurant in Laguna Beach Closes Doors***

We'll never know for certain whether or not our anti-foie gras campaign and repeated visits to the restaurant were a part of the cause, but Hush Restaurant in Laguna Beach recently closed its doors for good.

### ***Westminster BarkWorks Store Closes***

The Barkworks store at the Westminster Mall is now closed. KTLA recently ran a news segment about Barkworks' use of puppy mills to supply its puppies, and protesters have been targeting Barkworks stores around Southern California for some now.

### ***Bar in Long Beach Removes Lobster Zone***

A well-known bar in Long Beach recently removed its Lobster Zone after being contacted by a coalition of groups led by OCPA.

## **Action Items – Your Letters/Calls Needed**

### ***Urge Senators to Pass the Clean Energy Jobs and Oil Accountability Act (S 3663)***

Another oil rig in the Gulf of Mexico has recently exploded. This latest incident underscores the risks of offshore oil drilling -- and the urgent need for the U.S. Senate to pass critical legislation to help protect our wildlife and prevent the next oil catastrophe.

Please urge your senators to pass the Clean Energy Jobs and Oil Accountability Act (S 3663). The wildlife death toll from the Deepwater Horizon oil disaster has been staggering: more than 5,300 birds, 550 threatened and endangered sea turtles, 80 dolphins and other marine mammals. Hundreds of miles of coastline fouled with oil, including several National Wildlife Refuges -- havens for our most precious wildlife. But the long-term effects -- on our wildlife, our fisheries and our coastal economies -- won't be known for years.

The U.S. House of Representatives has already passed a strong bill responding to the worst oil spill in U.S. history. But the Senate is dragging its collective feet -- and may not even pass their version of the bill at all this year.

### ***Ask Governor to Sign AB 2743 and AB 2012***

AB 2743 will prohibit California landlords from requiring tenants to declaw cats or devocalize (debark) dogs. This bill has passed in the California Assembly and Senate. Please call and write to the Governor and urge him to sign AB 2743 into law. Declawing is illegal in eight California cities: West Hollywood, Los Angeles, San Francisco, Santa Monica, Beverly Hills, Berkeley, Culver City, and Burbank have approved declaw bans.

AB 2012 will increase the amount of jail time a judge may issue to a person convicted of animal neglect from the current six month maximum to 12 months. This bill has already passed both houses of California legislature by large margins with bipartisan support and also now awaits the Governor's signature.

### ***Sign Petition to Prevent Bear Baiting***

HSUS investigators recently attended several bear baiting events in South Carolina and were shocked by what they discovered. A captive bear -- claws and many teeth cut down or removed -- is tied up and abused for hours. The S.C. Department of Natural Resources gives permits to people who release teams of dogs to harass and bite terrified, defenseless bears.

Demonstrators met on Saturday, August 28<sup>th</sup> at 2:00 p.m. and Sunday, August 29<sup>th</sup> at 11:30 a.m. at the Oaks Bienheim Ranch Mission Viejo Riding Park in San Juan Capistrano on behalf of animals abused in the rodeo.

Many animals are injured and even killed in rodeos. Animal cruelty investigators are only able to attend a very small percentage of rodeos each year. Therefore, only a very small percentage of injuries or deaths are documented. More importantly, as the record below shows, rodeos frequently try to cover up animal injuries and even deaths. Injuries ranging from minor to life threatening may not be immediately visible, especially from the distance of the bleachers. These injuries may include sprains, broken bones, muscle pulls, saddle blisters, spur and flank strap wounds.

### ***Outreach for Campaign to Stop Trapping/Killing Coyotes – Saturday, September 25th at 4:00 p.m. in Arcadia***

OCPA members and friends met with activists in the San Gabriel Valley to help collect signatures from Arcadia residents on a petition that is opposition to the trapping and killing of the coyotes of Arcadia.

For the past decade, Arcadia has hired a pest control company to trap and kill coyotes in the city of Arcadia, CA. But for the past two years, due to budget cuts, the coyote killing program was halted. Then again this year, in a special meeting on August 3, 2010, the city council decided to pay the pest control company \$30,000 to trap and kill coyotes. In the first 10 days of the program, 11 coyotes were snare trapped and killed. Two of these coyotes were pups that were born in the spring.

This decision was made due to a few residents in Arcadia that have had their companion dogs and cats killed by a coyote because they failed to keep their companion animals safe inside. The rest of Arcadia's residents had no say in the matter and because the decision was made in a special session city council meeting it was not covered on the local Arcadia TV station that usually broadcasts city council meetings. The pest control company has one man killing these coyotes that are trapped. They claim that the

coyotes are killed by euthanasia, but there is word that he may be killing the coyotes in any manner he wishes, so we cannot be sure that these coyotes are not being bludgeoned to death (although this is not confirmed). For an abc7 story on the issue, visit:

Trapping and killing coyotes is not only inhumane and cruel, it is an ineffective way to decrease the chances of a coyote attack on a companion dog or cat. There are many more effective ways known as hazing tactics, which discourage coyotes from coming into neighborhoods. Also educating residents on how to avoid coyote attacks on their companion animals is a long-term solution. Just because coyotes are killed does not mean that other coyotes will not come into the neighborhood and replace them. And we must always remember that this is their home too. Humans have built cities and houses, taking up more and more of the wild lands, forcing wild animals to retreat more and more. So we must learn to coexist with them in a peaceful manner. ### ***Peaceful "Lobster Zone" Game Protest – Saturday, October 2nd at 7:00 p.m. in Long Beach***

Join OCPA and other advocacy groups on Saturday, October 2<sup>nd</sup> at 7:00 p.m. in Long Beach for a peaceful protest urging diners to boycott The Beach Club until the restaurant removes the cruel "Lobster Zone" game from its premises.

We have posters and leaflets; we just need your presence to help spread the word and educate passersby about this cruel practice. The protest will start at 7 pm and end at 9 pm.

If you've ever seen the arcade game in which players deposit a quarter and manipulate a large claw to grab a stuffed animal and drop it into a chute, you're familiar with the Lobster Zone concept. In the Lobster Zone, players pay \$2 to try to grab a live lobster and drop it four feet onto a hard metal surface. If it survives the drop, the terrified (and often injured) lobster is typically boiled alive and eaten.

Lobsters are intelligent animals capable of experiencing fear and pain. In the European Union, lobsters are treated as in the same class as dogs and cats with regard to capacity for suffering. Moreover, lobsters are solitary animals who prefer to burrow under sand and do not enjoy socializing with other lobsters. In the Lobster Zone tank, these animals are denied the ability to burrow, forced to interact with other lobsters in close quarters, and subjected to the constant, threatening menace of a huge claw. Observation of the Lobster Zone game shows that the lobsters consistently cluster together on one side of the tank, as far away from the claw as possible. Given their preference for solitude and space, their choice to huddle together demonstrates clearly that they fear and routinely avoid the claw.

Numerous animal advocacy groups are opposed to the Lobster Zone game, including People for the Ethical Treatment of Animals (PETA), In Defense of Animals, Last Chance for Animals, Orange County People for Animals, Compassion in Action, Animal Rescue Media Education, Band of Mercy, United Animal Advocates of Los Angeles, All-Creatures.org, Cease Animal Torture, Irvine Students Against

Animal Cruelty and Concerned Citizens for Crustaceans. Join OCPA and other groups in protesting this cruel game!

Many animals are injured and even killed in rodeos. Animal cruelty investigators are only able to attend a very small percentage of rodeos each year. Therefore, only a very small percentage of injuries or deaths are documented. More importantly, as the record below shows, rodeos frequently try to cover up animal injuries and even deaths. Injuries ranging from minor to life threatening may not be immediately visible, especially from the distance of the bleachers. These injuries may include sprains, broken bones, muscle pulls, saddle blisters, spur and flank strap wounds.
