Good News for the Animals!

Animal Legislation Updates

Thanks to your calls and letters, Governor Schwarzenegger recently vetoed the following animal-related legislation:

- **AB 815** would have taken away the rights currently afforded to cities and counties in California to enact local wildlife-related laws specific to their communities. If this bill had been signed into law, the state Fish and Game agency would have become essentially the only entity with the power to adopt laws or regulations regarding the taking of fish and game in California.
- **AB 2427**, broadly written legislation, would have prevented counties and cities from passing local laws that restricted procedures or acts within the "scope of practice" of the healing arts, including animal welfare laws that they deem necessary to protect animals from inhumane practices.
- **AB 2132** would have prohibited the removal of radio transmitting collars from hunting dogs and allowed hunters to charge violators for any lost breeding revenues.

And the following animal-friendly bills were signed into law:

- **AB 2098** strengthens existing law prohibiting auctions and state inspected slaughterhouses from receiving or dragging downed animals.
- **AB 2291** adds a check box on state income tax forms to finance low cost spay/neuter programs.
- **AB 2785** requires the Wildlife Conservation Board to designate and protect wildlife corridors.
- **AB 2911** strengthens protection against oil spills and provides for the better use of volunteers to rehabilitate wildlife.
- **AB 2949** requires property owners (such as banks and real estate agencies) to notify animal control when they find abandoned animals.
- **HB 2532** (passed the House) makes prohibitions about dog tail docking, dew claw removal and ear cropping; defines many common practices as animal cruelty.
- **SB 685** strengthens current California laws covering pet trusts.

Gray Wolves Retain Endangered Species Protection

Officials at the U.S. Fish and Wildlife Service (FWS) announced that they plan to rescind the agency's plan to delist gray wolves in Greater Yellowstone and the Northern Rockies sometime soon and place them back under federal protections. Thanks to your incredible efforts and support over the last few months, the Fish and Wildlife Service has finally bowed to reality by recognizing that there are serious scientific and legal problems with their plan for delisting wolves in Greater Yellowstone and the Northern Rockies.

Landmark Puppy Mill Reform Bill Passes in PA

Trying to shed its reputation as "The Puppy Mill Capital of the East," the Pennsylvania Legislature recently passed HB 2525, a bill that will improve the lives of tens of thousands of dogs living in Pennsylvania's puppy mills. Introduced in May, HB 2525 doubles the cage space required for dogs in Pennsylvania's commercial breeding facilities, prohibits wire flooring and the stacking of cages, mandates exercise and twice-yearly veterinary exams for all dogs, and requires that animals be humanely euthanized by licensed veterinarians.

Millionaire Mutts in Malibu Closed

After protesting two pet shops in Malibu for months (Millionaire Mutts and Pet Headquarters) and receiving a complaint from a customer who bought a puppy at Millionaire Mutts, LCA sent an investigator to Texas to check out the "good breeder," and discovered it was indeed a puppy mill. LCA's investigation since led to the recent closing of Millionaire Mutts.

Chicken Slaughter Project Stopped

After a year of pleading by United Poultry Concerns (UPC) to the Canandaigua Academy City School District to eliminate a chicken slaughter classroom activity conducted at Canandaigua Academy high school in upstate New York, the State Education Department informed the school district that the project requires a waiver under New York State Education Law Section 809(5) - Humane Treatment of Live Vertebrate Animals Law.

Education Law 809(5) provides that no school district, school principal, administrator, or teacher shall require or permit the performance of a lesson or experimental study on a live vertebrate animal in the school or during an activity conducted under the school's auspices, whether or not on school premises, where such lesson or experimental study employs termination of life.

To bypass this provision, a school must submit a detailed application to the Education Department for a waiver. Canandaigua Academy did not submit the application in time, claiming unawareness of this law. It is questionable whether a waiver will be granted given that the slaughter project is not being taught as vocational education, or for taking a state or national advanced placement examination, but, rather, for the purpose of acquainting students with "food production" and other goals that do not appear to fit waiver criteria.

H&M Adds Fur-Free Fox Logo

Earlier this year, Swedish clothing company H&M took a stand against the cruelty of fur fashion by joining the international Fur Free Retailer Program. Now H&M has gone a step further by adding the internationally recognized fur free fox logo to their website. The logo is prominently displayed on the company's [corporate responsibility web page](#) and features a link to the [international list of fur free retailers](#). With locations across the United States and more than 1,500 stores in 28 different countries, H&M has long been known for its affordable high quality fashions and its ethical business policies.

Oprah Shows Footage on Plight of Farmed Animals

The Oprah Winfrey Show recently brought attention to the horrific plight of battery-caged hens, crated veal calves, and pregnant sows confined in metal stalls. Oprah showed footage of the three standard types of commercial confinement systems, so-called factory farming. She also showed three less intensive types of systems: one in which veal calves lay together in a building with straw bedding, one where pigs roamed in a pasture, and one where thousands of hens used for egg production ranged on a stretch of open land.

Although more emphasis should have been placed on the adoption of a vegetarian/vegan diet as a way to end the abuse and exploitation of animals raised for food, the rallying point for the segment was California's Prevention of Farm Animal Cruelty Act, or Proposition 2, on the November ballot. Proposition 2 would require that these animals be given enough confinement space to stand up, lie down, and extend their limbs without bumping into other animals, walls or bars.

Juicy Couture Adopts Permanent Fur-Free Policy

PETA has had a cooperative relationship with Liz Claiborne Inc. and other retailers to help reduce the suffering of animals used and abused in the clothing industry.

Juicy Couture—a high-end clothing company owned by Liz Claiborne Inc.—has now adopted a permanent fur-free policy. While Juicy Couture is still selling some fur items that were stocked before this

policy was adopted, it has assured PETA that no new fur items will be procured and that as soon as the current stock of items has gone, the company will be completely fur-free.

Zappos.com Goes Fur-Free

Just one month after launching an online campaign against Zappos, PETA announced that the company has agreed to go fur-free. By making this commitment, Zappos is joining Target, QVC, the Home Shopping Network, Nike, Polo Ralph Lauren, Gap, Forever 21, Wet Seal, and dozens of other companies and designers that have gone fur-free.

eBay Bans Sales of Ivory on Website

Online auction giant eBay recently announced that it will ban sales of ivory via its website starting next year due to concerns that it is helping to fuel poaching of endangered elephants. The announcement was made ahead of a report released by the International Fund for Animal Welfare that tracked online wildlife-product commerce and concluded that eBay is the venue of choice for most online endangered-wildlife sales. Some 75 percent of online wildlife-product sales that were tracked in the study came from elephants, which prompted eBay's ban announcement. According to IFAW, over 20,000 elephants are poached for ivory each year in Africa and Asia.

Vote Yes on Proposition 2!

California voters are poised to cast a historic ballot for the biggest animal protection measure ever placed before the public. Volunteer campaigners have worked hard to place measures on state ballots in hopes of significantly improving the lives of animals. It's a form of citizen action that has proven highly successful, from Arizona to Massachusetts, Washington to Michigan.

The Prevention of Farm Animal Cruelty Act (Proposition 2) aims to prevent cruelty to animals in industrial factory farms, and help protect food safety and California's environment. This landmark ballot initiative combats some of the worst abuses in factory farming. If passed, it will end the practice of keeping veal calves, breeding pigs and laying hens in cages and crates so small that the animals cannot turn around.

Urge U.S. Representative to Support HR 6598, Prevention of Equine Cruelty Act

After passing through the Congressional House Judiciary Committee on September 23, H.R. 6598, the Prevention of Equine Cruelty Act, may be voted on by the full House of Representatives at any time. This federal bill will stop the slaughter of American horses, a cruel practice that continues in Mexico and Canada.

Although last year saw the closure of the final horse slaughterhouses in the U.S., more American horses than ever are being slaughtered for human consumption. Hauled over the border to Mexico and Canada, these horses, most of them once cherished, gentle family companions, are brutally killed by the cruelest of methods.

H.R. 6598 has passed the House Judiciary Committee and is now up for a vote by the full House. Time is short to act on this important legislation. Please contact your representative as soon as possible and urge him or her to cosponsor H.R. 6598, the Prevention of Equine Cruelty Act, and VOTE YES on the bill when it comes to the floor for a vote. Veggie/Vegan Luncheon/Dinner Club – Sunday, September 7th at 1:00 p.m. at Native Foods in Aliso Viejo

OCPA had a meet and greet luncheon on Sunday, September 7th at 1:00 p.m. at the new Native Foods in Aliso Viejo, welcoming Dr. Jim Gardner, animal advocate running for City Council in the city of Lake Forest.

The animal welfare community has a new champion and he needs your help. Dr. Jim Gardner is a Clinical Psychologist and former CEO of an internet marketing company who turned his back on both these worlds and now spends full time on animal welfare issues. What was once a hobby or avocation has now become an obsession.

Dr. Gardner was certified as an animal rehabilitation specialist and helped clean seabirds during the California oil spills and helped Salton Sea Pelicans recover from Botulism. In 2005 he went to New Orleans on three separate occasions to rescue animals.

But these were only the prelude. For the past two years, Dr. Gardner a group of 5,000 citizens in South Orange County have been advocating for local shelters. It seems that many cities in South OC use the county shelter, where admissions are actually growing and where the kill rate has remained stable at approximately 50%, one of the highest in California. In honor of World Farm Animals Day and to help spread the word about Proposition 2, OCPA members participated in the following events:

- **Prop 2 Leafleting at Palin Rally, October 4th**: Tatiana Freitas and Dina Kourda handed out Prop 2 leaflets and educated supporters of Alaska Governor and Vice Presidential Candidate Sarah Palin on the benefits of Prop 2. The crowd was somewhat receptive to the predicament of farm animals (despite the fact that Palin is an enthusiastic hunter who brags of her hunting abilities and ardently supports the killing of living beings in her home state).
- **Prop 2 Presentation for the Green Party with Robb Mead, October 5th**: Robb Mead and Dina Kourda made a compelling presentation for Yes on Prop 2 to the Green Party of Orange County. There were approximately 15 people in attendance and the audience was very receptive. Two of the Green Party's active members promote a vegan lifestyle on a monthly basis at these meetings.
- **Prop 2 Presentation for the clients and offices of Thomas Hewko, DC in Santa Ana, October 9th**: Dina Kourda appeared before 13 patients, office staff, and chiropractors at the offices of Thomas Hewko, DC in Santa Ana. On October 13th, Bryan and Christine of LCA and Julia of SAEN co-hosted a demo near UCLA medical center with approximately 17 demonstrators in attendance. Vehicular and foot traffic at both demonstrations were receptive to the message of invalid vivisection results paid with tax dollars and the suffering of its victims.

And on October 15th, Bryan and Christine of LCA and Julia of SAEN co-hosted a demo at the Cal Tech campus in Pasadena. More than 20 activists attended the protest at Cal Tech on a sweltering hot Wednesday afternoon to protest primate "brain mapping" research currently being carried out by Richard A. Andersen. Although there wasn't as much foot traffic at this location, over 200 flyers were distributed and many people stopped to find out more about what was going on inside the university. One lady who was driving by was compelled to stop and join in having never done a protest before.
