## **Good News for the Animals!**

### ***Deer Saved from Cruel Bowhunt in New York***

Teatown Lake Reservation, the largest non-profit nature preserve in Westchester County, New York, was planning a deer bowhunt starting in November, but animal advocates spoke out against it; the bowhunt was subsequently cancelled. Bowhunting is an extremely cruel method for killing deer. For most of the deer, death takes at least several minutes, while they experience intense pain and fear, and some stagger away and die days later from infection.

### ***Monkey Prison Stopped***

The Puerto Rico Senate recently approved Senate Resolution 1514 to "[e]xpress the most forceful objection" to Bioculture's plans, and will now officially "request that the United States Department of Agriculture (USDA) and the Fish and Wildlife Services (FWS) deny any and all permit requests by Bioculture Mauritius, any of its subsidiaries or Bioculture Puerto Rico, Inc. with the purpose of importing macaca fascicularis [macaque monkeys] into Puerto Rico."

Bioculture – a company that sells nonhuman primates to laboratories—has been dealt a massive blow after the municipality of Guayama, Puerto Rico, and its mayor, Glorimari Jaime Rodríguez, unanimously approved two landmark ordinances banning the import, export, breeding, and use of monkeys in experiments. Bioculture must now terminate its plans to capture more than 4,000 wild monkeys, confine them to cages, breed them in Guayama, and sell their offspring to laboratories for use in painful and deadly tests. Bioculture's client list included hideous labs such as Shin Nippon Biomedical Laboratories, Charles River Laboratories, Pfizer, and Covance, among others.

### ***Bill Clinton Goes Vegetarian***

Former President Bill Clinton told CNN's Wolf Blitzer recently week that he's trying to follow a plant-based diet. Apparently the effort began under orders from daughter Chelsea to get into better shape for her wedding.

### ***Chicken Suppliers Change Method of Killing***

Chicken suppliers Bell & Evans in Pennsylvania and Mary's Chickens in California are switching from the standard method of chicken slaughter (electric immobilization) to [controlled atmosphere killing \(CAK\)](#), becoming the first U.S. chicken suppliers to do so. This is a true milestone in the fight to help animals who are raised for food. [CAK](#) is a far less cruel slaughter method that renders birds unconscious before they are removed from transport crates. This development will help reduce the suffering of millions of chickens who are killed for food each year.

## **Action Items – Your Letters/Calls Needed**

### ***Urge Congress to Pass Pet Safety and Protection Act (HR 3907 and S 1834)***

The Government Accountability Office (GAO) recently released its report on the USDA's oversight of certain Class B dealers, who sell random source dogs and cats to laboratories. After reviewing USDA records for fiscal years 2007-2009 and interviewing USDA inspectors and the dealers themselves, GAO found fault with USDA management. It recommended USDA improve its analysis and use of traceback information to ensure that dogs and cats are obtained legally and collect and track oversight costs, because currently USDA cannot determine the amount of money being spent to regulate facilities under its jurisdiction.

This report seems further evidence of the need to simply shut down these random source Class B dealer facilities entirely, as called for in the Pet Safety and Protection Act, HR 3907 and S 1834.

### ***Ask Secretary Salazar to Stop Wolf Kills***

The Department of Agriculture and the state of Idaho are planning to kill up to 80 percent of the wolves in the central part of the state. They would decimate entire packs of wolves, gunning them down from helicopters and gassing defenseless wolf pups and their mothers after they've trapped them inside their dens.

The US Fish and Wildlife Service must study and approve the proposal. Ask that they intervene and stop this violent wolf killing proposal.

## ***Outreach to Save the Coyotes – Various Dates throughout October in Arcadia***

OCPA members and friends met every weekend in October with other activists in the San Gabriel Valley to help collect signatures from Arcadia residents on a petition that is opposition to the trapping and killing of the coyotes of Arcadia.

For the past decade, Arcadia has hired a pest control company to trap and kill coyotes in the city of Arcadia, CA. But for the past two years, due to budget cuts, the coyote killing program was halted. Then again this year, in a special meeting on August 3, 2010, the city council decided to pay the pest control company \$30,000 to trap and kill coyotes. In the first 10 days of the program, 11 coyotes were snare trapped and killed. Two of these coyotes were pups that were born in the spring.

This decision was made due to a few residents in Arcadia that have had their companion dogs and cats killed by a coyote because they failed to keep their companion animals safe inside. The rest of Arcadia's residents had no say in the matter and because the decision was made in a special session city council meeting it was not covered on the local Arcadia TV station that usually broadcasts city council meetings. The pest control company has one man killing these coyotes that are trapped. They claim that the coyotes are killed by euthanasia, but there is word that he may be killing the coyotes in any manner he wishes, so we cannot be sure that these coyotes are not being bludgeoned to death (although this is not confirmed). Trapping and killing coyotes is not only inhumane and cruel, it is an ineffective way to decrease the chances of a coyote attack on a companion dog or cat. There are many more effective ways known as hazing tactics, which discourage coyotes from coming into neighborhoods. Also educating residents on how to avoid coyote attacks on their companion animals is a long-term solution. Just because coyotes are killed does not mean that other coyotes will not come into the neighborhood and replace them. And we must always remember that this is their home too. Humans have built cities and houses, taking up more and more of the wild lands, forcing wild animals to retreat more and more. So we must learn to coexist with them in a peaceful manner. The Arcadia city council is not that interested in what non-residents think about the matter, which is why the focus is to collect petition signatures from Arcadia residents. So far the reception from residents has been pretty good. Because it was a decision made behind closed doors, not many of the residents know about the issue – and so we are enlightening and empowering the residents to take action for the coyotes.

## ***Peaceful “Lobster Zone” Game Protest – Saturday, October 2<sup>nd</sup> and October 9<sup>th</sup> at 7:00 p.m. in Long Beach***

OCPA and other advocacy groups met on Saturday, October 2<sup>nd</sup> and October 9<sup>th</sup> at 7:00 p.m. in Long Beach for a peaceful protest urging diners to boycott The Beach Club until the restaurant removes the cruel “Lobster Zone” game from its premises.

If you've ever seen the arcade game in which players deposit a quarter and manipulate a large claw to grab a stuffed animal and drop it into a chute, you're familiar with the Lobster Zone concept. In the Lobster Zone, players pay \$2 to try to grab a live lobster and drop it four feet onto a hard metal surface. If it survives the drop, the terrified (and often injured) lobster is typically boiled alive and eaten.

Lobsters are intelligent animals capable of experiencing fear and pain. In the European Union, lobsters are treated as in the same class as dogs and cats with regard to capacity for suffering. Moreover, lobsters are solitary animals who prefer to burrow under sand and do not enjoy socializing with other lobsters. In the Lobster Zone tank, these animals are denied the ability to burrow, forced to interact with other lobsters in close quarters, and subjected to the constant, threatening menace of a huge claw. Observation of the Lobster Zone game shows that the lobsters consistently cluster together on one side of the tank, as far away from the claw as possible. Given their preference for solitude and space, their choice to huddle together demonstrates clearly that they fear and routinely avoid the claw.

Numerous animal advocacy groups are opposed to the Lobster Zone game, including People for the Ethical Treatment of Animals (PETA), In Defense of Animals, Last Chance for Animals, Orange County People for Animals, Compassion in Action, Animal Rescue Media Education, Band of Mercy, United Animal Advocates of Los Angeles, All-Creatures.org, Cease Animal Torture, Irvine Students Against Animal Cruelty and Concerned Citizens for Crustaceans.

### ***Peaceful Elephant Ride Demo – October 9<sup>th</sup>, October 16<sup>th</sup> and October 23<sup>rd</sup> in Santa Ana***

OCPA members and friends met for peaceful demonstrations on Saturday, October 9<sup>th</sup>, 16<sup>th</sup> and 23<sup>rd</sup> against the Santa Ana Zoo's elephant rides.

Elephants forced to give rides are trained through domination, fear, and punishment with the use of sharp metal bullhooks and electric prods. A bullhook is a tool that resembles a fireplace poker. It's a long, heavy rod with a steel point and hook at one end that trainers use to strike the animals and jab into the most sensitive parts of an elephant's body. Bullhooks hurt elephants, often causing puncture wounds and abscesses.

Despite the terrible way elephants are treated, the Santa Ana Zoo still plans to force these animals to give rides weekend after weekend.

***Save Japan Dolphins Day – Thursday, October 14<sup>th</sup> at 12:00 p.m. in L.A.***

Save Japan Dolphins Day, a worldwide peaceful and lawful protest of the annual dolphin slaughter in Japan, as depicted in the Academy Award winning documentary The Cove and the Animal Planet series Blood Dolphins, was held on Thursday, October 14<sup>th</sup> at 12:00 p.m. in Los Angeles.

The Japanese government issues 23,000 permits annually to coastal communities to kill dolphins of several species. A few are sold, at great profit, to aquariums and swim-with-dolphins programs around the world. The captive dolphin industry subsidizes the slaughter. The majority of the pod are then slaughtered for meat. But the meat is contaminated with huge amounts of mercury and other pollutants, exceeding the Japanese government's own health limits. This is a human rights issue as much as an animal welfare issue.

Demonstrations were held throughout the world in front of Japanese embassies and consulates to protest the hunts and urge Japan to switch to more sustainable and benign methods of profit, such as eco-tourism and dolphin-watching cruises (ironically becoming more popular in Japan every year).

***Peaceful Protest at Pony Rides – October 15<sup>th</sup> and 22<sup>nd</sup> in Long Beach***

OCPA members and friends met on October 15<sup>th</sup> and 22<sup>nd</sup> to protest the cruel pony rides at a small fair in Long Beach.

The ponies were chained to a metal pole and forced to walk around in a small circle all day long. It's a life of enslavement and forced labor for the amusement of a few children and their parents. The pony rides were part of a small fair/pumpkin patch on Pacific Coast Highway in Long Beach, just south of Westminster next to a UA Cinema and across the street from Mimi's Cafe.

Bullhooks hurt elephants, often causing puncture wounds and abscesses.

Despite the terrible way elephants are treated, the Santa Ana Zoo still plans to force these animals to give rides weekend after weekend. We have signs and leaflets, we just need your presence to help advocate for the elephants!
